I called to speak with Jim Sullivan III concerning the response to the remedial action letter sent to Jim Sullivan, Inc. Sandi Lyons-Sullivan answered and indicated that Mr. Sullivan III was not in today. Ms. Lyons-Sullivan asked if I would like to speak to her father, Jim Sullivan, Jr.. I indicated that I have been working with Mr. Sullivan III and did not want to encumber her father with details that her brother (Mr. Sullivan III) is familiar with at this point. I said that we have been expecting details in regard to the remedial action letter for the site and was advised that Brinkerhoff would be providing said information. Ms. Lyons-Sullivan indicated that Brinkerhoff required advanced payment prior to providing the information to the NJDEP. Rodney Murray on Friday, June 2, 2006. Mr. Sullivan indicated that they hired Brinkerhoff Environmental to do the work we requested in our letter dated May 4, 2006. I asked whether the well testing and mercury vapor monitoring were being performed. Mr. Sullivan indicated that they would be performing all work required in the May 4 letter. I indicated that he needs to send me a written response indicating that they will be pursuing the required investigation, and upon receipt, we will determine which oversight mechanism will be most applicable for their site. Mr. Sullivan indicated that when he foreclosed on the property several years ago, he contacted the NJDEP on numerous occasions to determine whether any issues were outstanding, but he never received a response from the DEP. At that time, they hired Target Environmental to review the case file and Target provided them with the EPA report indicating there was no contamination above standard; yet 2 years later we (NJDEP) are advising him that additional work is required. As such he is quite frustrated. I advised that we understand his frustration, and we will try to help him through the process so we could resolve this issue expeditiously.

I called Mr. Sullivan requesting a status on the Memorandum of Agreement (MOA) sent under cover letter dated 21 June 2006. I indicated that the NJDEP had expected to receive the MOA on 10 July 2006. Mr. Sullivan indicated that he was unable to address portions of the MOA and requested assistance from Brinkerhoff. According to Mr. Sullivan, Brinkerhoff recommended moving forward with the indoor air sampling (for mercury) and potable water sampling, sending the MOA and data together to the NJDEP. Mr. Sullivan indicated that Brinkerhoff was to have the indoor air analysis to his office this week (24 July) and the entire package, MOA and supporting data, would be sent to the NJDEP by Friday, July 28th.
