Attached you will find the results of a Labor Committee survey. The survey afforded approximately half the membership an opportunity to express their opinions and evaluate the Command Staff. According to the final results, the membership is very dissatisfied. These results are extremely disappointing.

There were a total of 179 respondents to the survey.

1) Do you feel that your level of training is adequate for the position you currently hold?

3) Do you feel that you have the needed equipment to carry out your duties in case of a terrorist attack?

4) If you possess any special training or certifications, are they all current and up to date?

5) Do you feel the Command Staff of The U.S. Park Police are doing the best they can to protect the public?
