As you examine the following list, please note the following:

- Of 91 leases only 17 are current in their rental payments.
- Only 15 out of the 91 have current leases. Most of them have leases that are expired. Some leasees have a draft lease and have never gotten a final lease; others have expired Special Use Permits and have never been issued even a draft
- Tenants in residences on the list were allowed to occupy the buildings with the agreement that they would receive a rental abatement for renovation work they completed to the buildings. Those listed with outstanding rents have not provided any receipts or evidence of work they completed to the park office. (See attached
- Most of the easement leases are very low rental amounts that have accumulated

Page Two D&R Leases

In addition to the leases, a concessionaire has operated in the park for over 12 years without any kind of agreement. He operates a canoe rental in Princeton and Griggstown. This year he has added a Christmas tree business to our property in Griggstown.

As you can tell by the attached letters. I have made many efforts to collect rents as Paul Stern tried to do before me. However, I believe that I have no credibility when I write a letter that says the tenant faces eviction and two years later no action has been taken.
