## Mary,

I talked with Diane Souder. She is going to work with Joe to word a request for advice to Rob Eaton, who returns to his office on Monday the 14th. My concern is that we understand under what authority the NPS allows the stupa to remain on park property. At this point, I don't think we know what that authority is, or if we have it. We need to be prepared to answer the question, why are we allowing a religious shrine on NPS property? Diane will share that draft email with us tomorrow before it is sent to Rob. Can we afford to wait until Rob returns, or should we seek another solicitor's input? The important thing about Rob is that he is already conversant on this issue.

Diane and I also talked about putting a piece on the park web site covering the construction of the new amphitheater with a sentence at the end that says "The NPS has no plans for the stupa." Just as short and plain as we can get. Diane has spoken with a number of the folks in the local Buddhist community and given them assurances that we are not moving the stupa, and has also spoken with the author of the web site (who is the widow of the former owner of the house and stupa).

Diane let me know that she expects an article in the Albuquerque Journal over the weekend that will explain that the NPS has no plans to move the stupa.
