2003 Survey of EPA Office of Criminal Enforcement, Forensics and Training Employees Numerical Results

This survey consisted of questions developed by employees in the Office of Criminal Enforcement, Forensics and Training (OCEFT) of the U.S. Environmental Protection Agency. The purpose of this survey is to allow the professionals within the Criminal Investigation Division (CID) and OCEFT to express their views concerning the direction of the nation's principal program for criminal enforcement of our environmental laws.

There were five possible responses to each question. Percentage responses are shown for each possible answer, and the total number of responses for each question is shown in parentheses. Three hundred and thirty-six surveys were mailed, of which 35.7% (120) were returned.

RESOURCES

- 1. My unit is adequately staffed to meet its workload.
