Please find enclosed an invoice for your 1999 camplot lease fee with the Bureau of Parks and Lands. All checks should be made out to "Treasurer, State of Maine." Your fee is due in this office no later than May 1st, 1999. Payments made after that date will be subject to a late fee of \$25.00, plus a surcharge of 1% per month of the unpaid balance.

I wish to remind all lessees the importance of notifying this office in advance of any planned improvements to the leased area during the coming year. Repairs of a minor and routine nature normally do not require advanced notification. Refer to your copy of the Bureau's Policy on Seasonal Camplot Leases, or call this office should you have questions about this.

**Timely remittance of your yearly fee, and proper notification in advance of anticipated projects will help insure that the terms of your lease remain in force.**
