PER CURIAM ORDER [1840824] filed granting petition for writ of mandamus [1773608-2]. It is FURTHER ORDERED that the agencies file with the court a proposed schedule, within 120 days of the issuance of this court's opinion, for bringing all twenty-three parks into compliance within two years. Should the agencies anticipate it will take them longer than two years, they must offer specific concrete reasons in the proposed schedule for why that is so. The court will retain jurisdiction to approve the plan and monitor the agencies' progress. After the plan is approved, the agencies are directed to submit updates on their progress every 90 days until their statutory obligations are fulfilled. Before Judges: Henderson, Tatel and Griffith.
