Low System Pressure Compliance

Dear Mr. Helfrich:

The Palm Beach County Health Department (Health Department) has received information related to the operating pressures within the City's distribution system that appears to document various low pressure incidents (less than 20 psig). The information was submitted in the format of an anonymous complaint and the Health Department seeks your cooperation in evaluating the data and it authenticity.

The information provided to the Health Department appears to be daily printouts from the City's SCADA system showing the pressure readings for the following locations:

- L.LS031
- L.LS032
- L.LS084
- L.LS152
- L.LS163
- L.LS213
- L.LS216

The information indicates a total of 21 incidents during the period of April 2007 through February 2008 when pressures fell below 20 psig. Because the compliant alleges violations of Chapter 62-555, F.A.C. and the Palm Beach County Land Development Code, the Health Department does consider these allegations a serious matter. The Health Department's evaluation of this complaint is part of an agency investigation preliminary to any agency action.



In order to evaluate the information provided, the Health Department is requesting that the City submit both hard copies and an electronic copy of the pressure data for the following periods:

- September 26, 2007 September 28, 2007 (Midnight to Midnight)
- November 15, 2007 November 17, 2007 (Midnight to Midnight)

- January 14, 2008 January 17, 2008 (Midnight to Midnight)
- February 5, 2008 February 8, 2007 (Midnight to Midnight) and
- February 25, 2008 February 27, 2007 (Midnight to Midnight)

In addition, please submit copies of all notifications provided to the Health Department during the above periods that address either a boil water requirement or low pressure incident.
