^{**} In approximately 2013, Antietam National Battlefield installed a water bottle filling/hydration system at a park visitor center, and simultaneously asked its cooperating association to cease the sale of disposable plastic water bottles. The Washington Office is working with the Regional Director to collect approval documentation.

^{***} Fort Sumter National Monument received approval for its sales elimination program in October 2015.

Because the Regional Director had not approved the program by the time the original list of 19 parks was prepared, Fort Sumter was not included. It is included now.

**** Mammoth Cave National Park received approval for its sales elimination program in August 2015. Because the Regional Director had not approved the program by the time the original list of 19 parks was prepared, Mammoth Cave was not included. It is included now.

In accordance with PM 11-03, Part E, "Monitoring and Continuous Improvement," the NPS will continue monitoring these programs to determine their environmental effectiveness; impacts to visitor welfare, acceptance, and support; and effects on concessioners and cooperating associations. This provision also requires active outreach, conducted by the bureau, to a variety of professional communities and industries. Because of these examinations, the programs may be revisited to adjust their scope and to assess their strategic importance.
