Who : The Director of the National Park Service Midwest Region, Omaha, Nebraska made public that :

"Effigy Mounds National Monument Superintendent Phyllis Ewing has been relieved of her duties, today was her last day."
Florencia Wiles, Administrative Assistant has been named Acting Superintendent until another individual from outside the park will be named Acting Superintendent next week. The Regional Director will travel to Effigy Mounds National Monument on Wednesday May 26th, to meet with the park staff. A day earlier on Tuesday, May 25th an advisory council including members of the 12 affiliated tribes will meet at 8:30am with the State Historic Preservation Officer & National Park Service regional office personal including archeologists to discuss the very sensitive issues at hand, those being the impact to

the burial grounds and natural resources at Effigy Mounds N.M. and what types of remediation & mitigation can be done to correct these regrettable events. Both meetings will take place at the Monument's Visitor Center auditorium.

It is shocking that the very agency entrusted with the preservation of our nation's antiquities have actually negatively impacted on them. Superintendent Ewing and other employees at Effigy Mounds National Monument wantonly ignored laws to insure compliance that would have alerted the tribes, the historic preservation officials as well as archeologists to their development plans. They simply went forward with the construction of huge boardwalks, maintenance building & maintenance trails. This illegal activity began back as early as 2001. It is not public knowledge at this time what other employees may be" relieved of their duties". These actions are federal offences that could be punished with incarceration in a federal prison according to an NPS official.

Effigy Mounds National Monument was established by Presidential Proclamation on October 25, 1949 to protect significant prehistoric earth mounds found in NE Iowa. Subsequent legislation expanded the purpose and significance by specifying the wildlife, scenic and the other natural values of the area.

What : Impacted on Pre-historic Indian burial mounds with construction of boardwalk trails & other construction activites. Failed to file legal compliance reports. Wasted many 100s of thousands of tax dollars.
