Old Business

Yellowstone Volcano Observatory Wireless Webcam Proposal – Jacob Lowenstern - No intention to put streaming video on web for public viewing, also, will not put a webcam in the backcountry unless seismic activity requires watching. Webcam will be put at Lake Butte where seismic equipment already exists, webcam will not be visible. The webcam will only download still pictures over the Lake, not streaming video. Include in notes that when deploying webcam, Jacob should be working with the Wireless Committee and Park Geologist. The Wireless Committee will determine if each deployment is consistent with Appendix A of the FONSI and Wireless Plan. Jacob should notify the Wireless Committee and Park Geologist of what, where and when, deployment is needed. Wording of proposal should say approval of YNP instead of YNP Management.

Wireless Data Logger Proposal – Jacob Lowenstern - Data logger would replace existing equipment that requires travel in Geyser Basin to collect data, and would be manually downloaded. This proposal will be recommended for approval.

New Business

Change format of proposal form – a signature should be added for all Committee Members and signature line and comment section should be added for Superintendent. A Yes/No box should be added to determine if proposal adheres to WCP. A Recommend to Superintendent for approval/denial/other (other to be explained in remarks) section should be added.

Informational Updates

Cell Booster in ambulance proposal - previously proposed cell boosters in ambulances, these were installed and have been effective. Expands coverage approximately 2-3 miles on average Alltel – Co-location with Verizon at Elk Plaza, Addendum to ROW at region solicitor's office, 7 day period ended yesterday, should be receiving any day. Telecom should submit wireless proposal form for any new or changed cell sites, anytime wireless location involving structures are being moved. The Wireless Committee can track time and progress of proposals. Have Dustin write proposal for Alltel as project lead

Verizon – SF 299 for Fishing Bridge/Lake new cell site will begin sometime after the new year. 120 day clock will begin as soon as SF299 is received, yes/no/maybe period over after 10 days. Need to list on Federal Register and put on the street for public comment within 120 day time frame. Proposal is for 100' tower at Lake water tower site, tower will be just above tree line. 120 day time frame can be extended if needed

Superintendent Suzanne Lewis, verbally concurred with this location approximately 2 months ago. Verizon should submit to YNP another engineering proposal at selected location, along with computer generated visual simulations of what cell tower will look like from specified locations. Should have a feasibility assessment, and should visit with Verizon and tell them what the FONSI says is needed and what they should do, also provide them a copy of the FONSI with pages 43 and 44 bulleted. Tell them tower should be as close to invisible as possible. Both ROW's should go on proposal form, info is needed in order to make recommendation. Process should be run through before or fairly close to when ROW is submitted. Approval process should be initiated, as well as getting visual and disturbance information (what color tower will be and what kind, lattice, monopole, tree look).

A description of any vegetation manipulation including tree trimming or removal that would be required... (WIRELESS COMMUNICATIONS SERVICE PLAN, FONSI, APPENDIX A., pg 44)

Proponents must coordinate ground-based telecommunications requirements with the Telecommunications office prior to permitting and compliance review. Any required work must be shown on the submitted design and construction documents. (WIRELESS COMMUNICATIONS SERVICE PLAN, FONSI, APPENDIX A., pg 45)

Applications for WCF's taller than 20 feet above the surrounding tree height would require a detailed explanation of why a shorter tower is not feasible. (WIRELESS COMMUNICATIONS SERVICE PLAN, FONSI, APPENDIX A., pg 46)

In the mean time I will be following the steps in RM-53 which are:

- notify other Telecommunications companies in area of receipt of application
- initiate NEPA/NHPA compliance (applicant pays all costs) already complete in FONSI
- determine appraised or comparison value fee amount
- · estimate of costs to applicant
- initiate FOTSC technical review and analyze resultant comments upon receipt
- other as needed
- · initiate public comment period
- publish notice in Federal Register

Let me know if you have any questions I will do whatever I can to help you out here. The wireless committee was excited to get the SF-299 and see this project getting under way.

Cellular Service Proposal at Lake

Process:

- 1. Meet with Telecommunications Committee to discuss and review the proposal
- 2. Send the company a reply that does one of the following: "Accept" Proposal, "Deny" Proposal, Reply with a "Maybe" to Proposal
- 3. Post a legal notice in the newspapers for both Teton County, WY, and Park County, WY, to inform other interested telecommunications companies of the proposal
- 4. Prepare a press release to inform public that the park has received a proposal and to let them know what our process will be in order to reach a decision regarding the proposal.
- 5. Hold public meetings to inform the public about the proposal
- 6. Prepare a recommendation from the Telecommunications Committee to the Superintendent of Yellowstone National Park to either approve or deny the proposal
- 7. Prepare a notice for the Federal Register that a proposal has been received to provide cellular service and a need for an associated "Right of Way" permit for the facility.
- 8. A decision will be made by the Superintendent to approve or deny the proposal
- If the decision is to approve the proposal, the Telecommunications Committee would work with
 the cell phone service provider to ensure that the proposal and design of the facility would
 adhere to any requirements of the Wireless Communications Services Plan/Environmental
 Assessment (EA) and Finding of No Significant Impact (FONSI)
- 10. If the decision is to deny the proposal, then no service for cellular phone would occur at this time.

Yellowstone has received a proposal from a cell company to install a WTF in the Lake area. Currently we are reviewing the proposal and working through the processes outlined in RM-53. Cellular Courtesy Signage: Briefing memo to be sent to the Superintendent summarizing the sign layout, initial siting considerations, newspaper and website entries for approval, and draft plans for subsequent seasons is pending. Decision was made to move the "no cell" symbol to the bottom of the announcement in the summer issue of the park paper. If the Superintendent approves the WTC Cellular Courtesy proposal, we will contact Lori Gruber with the final design to produce and deploy signs.

Notification Letters to FCC License Holders in Teton County RE: Lake WTF and Cell Tower: Notification letters were drafted, approved and sent to eleven license holders informing them that we had received a request for a right of way for a cell tower and wireless telecommunications facility (WTF) at the Lake developed area. The park asked that the license holders respond within 30 days of receipt of letter. Received request for co-location from Union Wireless for the facility requested by Verizon at Lake.

Proposals

Internet Service Plan for Xanterra Concessions – Plan was proposed to the Committee earlier in 2009, it has not been recommended to the Superintendent for approval, more detailed plans have become available. Received a Wireless Proposal Form from Judy Jennings, Committee added comment stating that Xanterra would need to insure that the signal strength in the Mammoth Lounge would not spill over into the Mammoth Hotel lobby to avoid restricted areas in accordance with Table 1 of the FONSI. The form was approved by the Committee and recommended to the Superintendent.

Informational Updates

Digital Skylines WCF Application for Lake: Waiting to initiate Federal Register Notice until requested photo simulations and NIER is received from Verizon on the proposed site. Press Release will be released simultaneously with Federal Register Notice. After Federal Register Notification, 120 day clock will start, on day 90-100 public comments will be received and analyzed prior to any recommendation by the committee, or, day 100 the park will make a final decision, then it will be recommended for regarding approval (or disapproval) to by the Superintendent.

Alltel SF 299 request to co-locate with Verizon at Elk Plaza: The Superintendent sent the ten-year right of way, 1577-09-0020, to Alltel. Waiting for Alltel's agreement to the conditions on the right of way as written, they will send three signed copies to the park. The park will send the three signed documents with letters to the Regional Director. Once the right of way is signed by Region, Alltel will need to negotiate a contract with Verizon, and then they can begin installation. Alltel has been out of service in the Mammoth area since the removal of the Bunsen Peak Tower on March 20, 2009.

Roundtable - Non Agenda items

Discussed starting on 10 year ROW's for Verizon for existing infrastructure at Old Faithful, Grant and Elk Plaza. Reiterated that committee will expect the Old Faithful tower to be moved during the early portion of any new agreement part of the discussion. The 10 year ROW agreement would start in October.

Cellular Courtesy Signage: A briefing memo will be presented to the Superintendent summarizing two sign samples and site location maps for Mammoth and Old Faithful.

Lake Verizon Cell Tower Proposal: Verizon submitted photo simulation that were rejected and returned as unacceptable because they did not include maps and viewpoints from the Grand loop Road locations southeast of the corrals, the East side of Fishing bridge, and the Lake employee housing area. After complete and acceptable photo simulations are received, a proposal will be made to the Superintendent for review and approval. After proposals are reviewed and approved by the Superintendent's office a notice will be published in the Federal Register along with press releases coordinated with the PAO. Verizon will submit an SF299 Request for Right of Way. If Verizon and the Regional Director agree on a right of way construction on the WTF and tower can begin.

October Expiration of Right of Ways: The current one year extensions of the existing right of ways will expire in October. Verizon requested that the NPS begin drafting the new ten year right of ways now instead of waiting for the October deadline. Committee agreed to begin drafting new ten year right of ways for Elk Plaza, Grant, Old Faithful, and Mt. Washburn. The existing right of way was one right of way with addendums added for each new WTF. The new ten year right of ways will be written individually for each tower, site, and provider. A briefing will be given to the Superintendent before the new rights of ways go out to the providers.

Old Faithful Cellular Tower: A briefing will be given to the Superintendent for a proposed alternative WTF and tower site at a June 22 meeting with the Planning office and the Wireless Telecommunications Committee. If the Superintendent supports the consideration of an alternative site the Committee will ask Planning to include it in the Old Faithful comprehensive planning process. The committee will request engineering and photo simulations of both proposed sites at Old Faithful before a proposal is presented to the Superintendent.

Washburn Antenna Migration PMIS Project: This project received IMR approval, and has been forwarded for approval in Washington. If approved in WASO, projected start-up for Engineering would likely occur in FY 11. The Committee has a goal to develop three alternatives to consider for the antenna migration project identified in the Wireless Telecommunications EA and FONSI.

Proposals

The Telecom to Garage Wireless LAN proposal, previously recommended for approval to the Superintendent, was rejected on technical grounds by WASO and the NTIA in region because it specified a 2ft open mesh parabolic dual plane antenna instead of the approved 4 ft solid dish. A modified proposal was received by the Committee from Supervisory IT Specialist Andy Bilton. The committee will

Lake Verizon Cell Tower Wireless Proposal: Committee spoke with John Sacklin Yellowstone process for Federal Register Notices. Lee Dickinson, Regional Program Manager, sent an email to committee stating that the solicitor had not reviewed the Federal Register Notice application but had concerns, also, that the Federal Register Notice should not be published as it is policy not law and that the notice to General Circulation Media and Federal Register Notice did not conform with timeline given in RM53. Committee agreed to go ahead with the Federal Register Notice. The Federal Register Notice states that we should reference the Wireless Plan EA on the PEPSI website and that we create an email address and website with a high level overview of the proposal. Tower installation is stalled due to Qwest fiber installation to Gardiner. There will be a press release sent out simultaneously with the Federal Register Notice

Proposals:

Cellular Courtesy Signage: Committee routed via pink slip to Linda Young and Lindsay Robb for review. The wording was changed slightly on the signs and there were new locations added. The proposal was approved and signed by committee and will be recommended to superintendent for approval. After approval, signs will be printed.

Directional Antenna at Norris Geyser Basin: Proposal by Christie Hendrix for Robert B. Smith, YVO and University of Utah. Proposal requests a 12" L Yagi antenna be placed in the storage cabinet at the Norris Museum and a small antenna be placed at GPS/Seismic Station. Committee agreed to request a site plan and ask where the antenna would actually be at the GPS/Seismic Station. The committee stated that they would approve alternative 2 of the proposal and that Tobin Roop should be consulted for cultural concerns. Committee asks if the antenna would be visible to the public, what the specs are for the antenna, the location and mount height, where it's going and what it will look like. Committee will ask for additional information.

Vehicular Cellular Boosters for Emergency Vehicles: Proposal by Tim Reid, Chief Ranger. Proposal is for vehicle cellular boosters to be placed in ambulances and law enforcement vehicles for better cell reception. Committee agreed that proposal adheres to WCP for emergencies. Proposal was approved and signed by committee and recommended to superintendent for approval.

Vehicle Cellular Booster for FuelMaster at Grant Village: Proposal by Gerald Bartlett. Proposal is for a vehicle cellular booster to be placed at the Grant FuelMaster site to communicate fuel usage data to a collection site at Mammoth. Committee agreed that proposal is within developed area and is within the FONSI. Proposal was approved and signed by committee and recommended to superintendent for approval.



Proposals:

1610 Radio Installations at West, South and East Entrances: Proposals are for installations of AM1610 frequency information and emergency radios. These would be replacing previous installations. The committee recommended going back to the proposals and modifying them to reduce visual impacts putting them closer to surrounding structures or otherwise making them unobtrusive through use of the best available technologies (e.g., stealth technology, slimline poles, enclosed antenna, and micro-cells), screening with vegetation or existing topography, concealment, and/or camouflage. As stated on page 46 of the FONSI. Committee will meet with Mike Angermeier to discuss proposal revisions. No action taken.

Northeast Entrance Seismic Station: Proposal was returned to committee by superintendent with concerns regarding proposed wilderness. This was determined not to be in proposed wilderness. Committee resigned proposal and routed it back to the superintendent for signature.

Verizon Network Extender: Proposal was returned to committee by superintendent because there was no sunset date for testing. Committee will give a timeframe in the comment section of proposal and reroute to superintendent.

Informational Updates

Draft 2010 Annual Report: Committee looked over draft and recommended some changes. Changes will be made and then Annual Report will be routed to superintendent for approval. After approval is given, this will be made available to the public on the PEPC website and included in the Superintendent's Annual Report.

AT&T Mobility ("ATT") proposed modifications to the former Alltel wireless site on Mt. Washburn:

ATT acquired many former Alltel sites. General Dynamics represents ATT for purposes of integrating the acquired Alltel sites into the ATT network. Upon completion of the integration process, all ATT subscribers, and subscribers of ATT roaming partners, would have wireless service capability from coverage provided at the Mt. Washburn site. Union Wireless' (ATT) right of way expires October 21. On the SharePoint site you will find documents provided by General Dynamics (the contractor) 1) a detailed description regarding the proposed modifications and, 2) a high level view of the implications and importance of completing the modifications in a timely fashion. There will be two new temporary relay site installations to upgrade existing sites. Committee discussed the changing of ownership. There will be no change to the coverage areas.

Roundtable - Non Agenda items

Druid Peak Repeater: MRA for the permanent repeater was not completed because the Radio Shop wants to monitor snow patterns at the site over the Winter to be sure the area would not be drifted over. The application will come out in the Spring for the permanent repeater.

Lake Cell Tower: This is at the Federal Register Notice level and is being discussed between solicitors in Region and Washington. The solicitors are conferring on the need for a Federal Register Notice. The project is relying on Qwest getting DSL to Gardiner for more access to the park. Qwest is currently stalled at Yankee Jim Canyon due to Forest Service ROW's. If Qwest gets there equipment to Gardiner, the tower should be installed in the Spring.

Proposals:

Yellowstone Association Wireless Internet — It was discovered in February that the Yellowstone Association installed Wild Blue internet service and a wireless router for guests and employee internet service at the Lamar Buffalo Ranch. Apparently they were not aware of the wireless plan and the proposal process. The Committee will reach out to YA and inform them of the Wireless EA procedures. Committee agreed to have YA submit a retroactive proposal and provide pictures and details of the site to be sure it is consistent with the Wireless EA and to clarify the scope and breadth of the installation. The Wireless Committee has discussed proposal and approval requirements IAW with the EA to Concessioners, and NPS through several forums, but missed park cooperators such as the YA.

USGS YVO Webcam— Jake Lowenstern of the YVO informed the committee of a future proposal to move the YVO webcam from Lake Butte to Biscuit Basin. The 12/20/09 approved proposal states that the YVO will notify the Committee prior to moving the webcam to seek park input.

Informational Updates

Washburn Antenna Migration Engineering: A Scope of Work regarding the three proposals that will need to be submitted for approval is being assembled with the help of the Procurement office. No formal documentation is needed regarding conservation planning and environmental impact analysis, Reference Interim Guidance, Director's Order 12 Categorical Exclusions Section 3.3V which states "Preparation of internal reports, plans, studies and other documents containing recommendations for action which NPS develops preliminary to the process of preparing a specific Service proposal or set of alternatives for decision." Contractor would hold meetings for public input on the decision of which of the three proposals should be used. Contract should be out by fall and the public meetings next spring. The committee should be involved in the pre-solicitation meeting.

Lake Cellular WTF Site: Speaking with solicitor and attorney in DC regarding whether or not an Federal Register Notice (FRN) should be completed and what language should be used. If solicitor advises not to do the FRN would request a letter from them explaining why FRN should not be done. Committee believes the FRN should be done. An SF 299 was received from Verizon but they are not following the timeline because they are not able to get bandwidth to run the tower at this time. Construction on the tower will not start until bandwidth is available.

PMIS Spending plan for FY11 and Bunsen Peak CEV: After some adjustments, park is still over budget in FLREA project requests for FY11. For now, superintendent agreed to let things settle with the cuts we made so far (these and similar from other divisions) and continue to refine our programming for this year. Squad will meet again to review the status of our FLREA budget plan in about 2-3 months to see what has changed. If nothing, then we'll have to make some tough decisions across the park about what projects to cancel. Based on this and technical aspects (logistics with weight for helicopter) the Bunsen Peak CEV will be postponed for FY11.
