<b>NPS Management of Recreational Hunting</b>		
<b>State</b>	<b>Unit</b>	<b>Park Policies, Guidance, and Regulations that are More Restrictive than States</b>
AK	Multiple	The NPS published a proposed rule in 2018 to amend its regulations for sport hunting and trapping on national preserves in Alaska to establish better consistency with State of Alaska harvest regulations on surrounding non-Federal lands and waters. The proposed rule would remove regulatory provisions issued in 2015 that prohibit certain sport hunting practices that are otherwise permitted by the State of Alaska.
AK	Western Arctic National Parklands	There are some areas along the Noatak River where hunting is restricted to qualified subsistence users per decisions by the Federal Subsistence Board.
AK	Bering Land Bridge National Preserve	The Federal Subsistence Board put into regulations a series of Federal public land closures to the harvest of moose and muskoxen by non-Federally qualified users in accordance with Title VIII of ANILCA (Public Law 96-487) both for conservation purposes and to provide for the continuation of subsistence uses, and reduced the number of Federally qualified subsistence users who could hunt.
TX	Lake Meredith NRA	The park does not observe fall gun turkey season as outlined in the Texas counties because the overlapping hunting seasons with different hunting means and methods created public safety concerns.
OK	Chickasaw NRA	Hunting is permitted, but quail, snip, woodcock, rabbit, and squirrel hunting is closed during the first 9 days of deer gun season to ensure public safety. Some areas within the park are open to archery hunting and shotgun hunting with pellets only.
WI	Apostle Islands NL	Hunting and trapping are not allowed from May 15 through Labor Day. Trapping methods for upland habitats are restricted to cage/box traps or cable restraints on islands. Hunting and trapping are not permitted on Gull or Eagle Islands.

SD	Badlands NP	In the South Unit on tribal lands within the Pine Ridge Indian Reservation, hunting is subject to Oglala Sioux Tribe permits and limits.
AR	Buffalo NR	Buffalo National River is open to hunting and regulated by non-conflicting Arkansas Game and Fish Commission (AGFC) Regulations. Buffalo National River is a Wildlife Management Area (WMA) and is considered WMA Zone 080 and WMA Zone 620 (Lower Wilderness Area). Buffalo Point Area (Lower District) "No Hunting Zone" restrictions have changed to increase the area to be hunted, and the additional area is open to archery only, other AGFC Regulations apply. The park does not permit the use of dogs for chase pleasure and training. Trapping is prohibited except on private inholdings and agricultural permit holders may trap feral hogs with a special use permit from Superintendent's Office if field damage is occurring. All areas within the park are closed to viewing wildlife with use of artificial light.
NE, SD	Missouri NRR	Hunting is allowed on private and State-owned lands within the park boundaries. Hunting is open on one park property (about 200 acres) and closed on two park properties (about 90 acres). The number of deer stands is limited and how long stands may be left in place is limited. Additionally, the Draft Goat Island Management Plan that is under internal development calls for the Island to be designated as a special management use area where archery methods will be allowed for the harvest of whitetail deer and other species (e.g. turkey, etc.). Firearms will not be permitted to be used on the Island, with the exception of shotguns during waterfowl hunting on the sand flats in accordance with existing State laws.
MI	Sleeping Bear Dunes NL	The park works with the MI Department of Natural Resources to facilitate a special deer hunt on North Manitou Island. A MI deer hunting license and a park hunting permit are required. No baiting is allowed and there are no bag limits during this special hunt.
Multiple	Appalachian NST	Hunting is not allowed on the ~900 miles of the Trail that pass through national parks and most State parks. Hunting is permitted along the ~1250 miles of the Trail through national forest lands, national recreation areas, and State forest and game lands.
MD	Assateague Island NS	The park does not allow dogs for the take of rabbits, the season on bobwhite quail has been discontinued, and the park does not allow the taking of wild turkey.

MA	Cape Cod NS	Only deer, upland game (including Eastern Wild Turkey), and migratory waterfowl may be hunted in the park. To protect the public's safety and to prevent conflicts between hunting and other National Seashore uses, the Superintendent has closed certain areas and time periods to hunting. Hunting is prohibited from March 1st through August 31st each year, except for the taking of Eastern Wild Turkey as designated by the Superintendent.
PA	Delaware Water Gap NRA	All National Park Service owned lands are closed to hunting on Sundays. Hunting from a tree stand is only allowed from portable tree stands. Hunting in standing (unharvested) crops is prohibited. The viewing and attempted viewing of wildlife with an artificial light is prohibited.
ME	Katahdin Woods and Waters NM	Under the Monument's deed, hunting of bears with bait or dogs is prohibited.
ID	Hagerman Fossil Beds NM	Hunting is allowed only within the 50 ft. elevation of the high-water level of the Snake River per statute.
LA	Jean Lafitte NHP and Pres.	The park limits hunting and the take of outlaw non-native ungulates by designating hunt zones and periods when no hunting is permitted for reasons of public safety. The park consults with the State on those limits at least annually. Park limits are included in Louisiana's annually published hunting regulations in the Federal lands schedules section. The park also limits species and methods of take to wildlife that has been traditionally hunted in the area by means that maintain public safety and do not cause unacceptable damage to park resources. The park produces a written determination justifying the action at least annually in the Superintendent's Compendium.
KY, TN	Big South Fork NRRRA	Hunting bears is not allowed in the park until population data is available in both States to evaluate the sustainability of the Cumberland Plateau bear population. The park will develop an approach to hunting once the data has been gathered.
TN	Obed WSR	Hunting bears is not allowed in the park until population data is available to evaluate the sustainability of the Cumberland Plateau bear population. The park will develop an approach to hunting once the data has been gathered.
