Robert,

You may remember me from our work on the CRA and Eastern Interior Resource Management Plan matter. I have recently been detailed from my position in the Solicitor's Office into the position of Deputy Assistant Secretary for Human Capital and Diversity position on an acting basis.

The GAO Vacancies Reform Act report was tasked to this position but it unfortunately was never completed. I apologize for our extraordinarily long delay.

I have taken on the responsibility to submit this report in my current role. Toward that end, I have gathered reports to provide to you using the form GAO has established and I started to review them today before I go on leave next week.

I had hoped to sign a letter today transmitting Interior's report using these forms but, unfortunately, my review indicates that the data is not complete and in some cases it is incorrect.

I can report to you now that the Interior Department has no acting officials in PAS positions. We have filled the following PAS positions:

- 11. Inspector General
