The Most Recent Revisions To List of Corps Projects Under Review

On April 30, 2002, the Corps announced that it would subject approximately 150 projects in its construction backlog - projects previously authorized but not yet under construction - to a "rigorous re-evaluation" citing "serious questions in regard to the accuracy and currency of economic analyses."

Three weeks later, on May 16, the Corps declared that it had reviewed 171 projects, clearing all but 8 for completion.

Late in the evening of May 23, the Corps posted a revised list on its web site, cutting the total number of projects under review to 164 while declaring that 53 projects for which the Corps had previously completed its review were now to undergo additional but unspecified "re-evaluation."
